

Suggested Changes to - 1054 Hyde Park Cemetery.pdf (19/03/2007)

as at 14 Jan 2019

The following are changes that seem to be required to improve the accuracy of the information included in the Hyde Park Cemetery Registers as published by Doncaster & District Family History Society (DDFHS).

These changes are suggested to correct inconsistencies in the final results that could have been caused at any stage in the recording processes from initial creation of the registers through monumental inscription engraving to final typing. If it is considered desirable to keep the original information then a possible answer would be to add a second entry with the same layout but containing the corrected information.

The work to identify these issues as been carried out on a voluntary basis using a CD purchased from DDFHS.

I started out with just these three issues ...

But then I started to dig a little deeper and now I have a long list that I expect to keep on growing ...

A large percentage of the issues identified relate to the cemetery section numbers – for example Section Rnnn being recorded as well as Section RXnnn for the same family. Sometimes the correct section can be confirmed by looking up the corresponding MI in the PDF. However if no MI exists then these cases will require further investigation and, most likely, access to the original sources. Also the section number issue can only be spotted where there are two or more entries for one surname in the same grave. Spotting errors on single entries would need access to the files used to create the PDF. Because of the large number of similar errors found the fault could start as far back as the original registers.

At Hyde Park these differences in section letters are important when finding a grave because the named sections are widely separated. In the case of Section R and RX, for example, they are at opposite ends of the cemetery.

The suggested changes are listed below and arranged by the PDF page number which should appear in a prominent position on your PDF reader app or web browser. However these remain suggestions based upon judgement rather than proof. Finally it would be good practice to standardise the plot references to three numeric digits ie 001 to 999. This would mean that plots are listed in the correct sequence and should highlight if a digit is missing.
